This exclusive International Program has been designed by *The University of Chicago (Graham School of Continuing Liberal and Professional Studies)* and the CEU San Pablo University. The objective is to train students in the exciting field of International Political Economy.

This multidisciplinary program analyzes the close relationship between economics and politics in a globalized environment. It aims to understand how national and international geopolitical factors interact with economic factors in different settings, such as international trade, the finance world, natural resources, etc.

The courses will be taught by professors of *The University of Chicago*. The program will endow the student with the knowledge and tools necessary to better understand the economic and political circumstances of the current world.

It is an excellent opportunity, offered by one of the leading universities in the world, for students interested in either the public or private sector. (*The University of Chicago* is positioned in second place in Economics and Social Sciences in the *Shanghai and Times Higher Education* rankings of world universities).

Practical Information

Stay at Chicago

The program is five weeks long, from June 22nd till July 25. It will be held at the campus of *The University of Chicago*. The fees cover the cost of the courses, accommodation, food and medical insurance. Students will be hosted at one of the university's dormitories. Full access to the university's library and sport facilities will be provided.

Who can enroll

The program is meant for university students (undergraduate and graduate) in Economics, Business Administration, Political Science, Law and International Relations. It is also available to professionals working in the fields of economics and finances, consulting or international law. Politicians, political scientists and journalists may benefit from this program as well.

Current and former CEU students will be given preference. Applicants from other universities or companies should satisfy the necessary pre-requisites. Applications will be considered strictly by order of registration.

Contents of the Program

The program consists of four courses on International Political Economy and a capstone Project. The courses will be the following:

- *Macroeconomics*
- *International Law and Organizations*
- *Politics of Globalization and International Trade*
- *Political Risk Analysis*

The medium of instruction is English. Applicants must have a minimum TOEFL score of 104 (*Internet Based Test*), with minimum scores of 26 on each section. An overall score of 7 in the IELTS is also accepted (with a minimum score of 7 on each section).

Application Period

In order to allow sufficient time to complete the American visa procedures, the registration must be completed by **April 15th**. Given the limited number of seats available, applications will be considered on a first-come, first-served basis.
